Subject:	Fireworks Or	dinance		

Staff was asked by the Board to research the feasibility of increasing restrictions on fireworks within the city limits, specifically to review a potential change to the ordinance to expand language to include arial fireworks. Currently, the Smithville ordinance states that no bottle rockets shall be discharged within the City limits except within an approved display. This is the only restriction placed on fireworks (aside from the approved times of discharge).

Staff researched ordinances in place in communities around the metro and compiled the enclosed summary fireworks ordinances. Staff also reached out to a number of communities identified as similar to Smithville to discuss their specific ordinance, how it is enforced, and the success of enforcement. Of the 19 municipalities reviewed, four do not allow any fireworks, four (including Smithville) restrict bottle rockets only, seven restrict bottle rockets and other types of fireworks and four have no restrictions on fireworks.

When staff discussed restrictions with officials (usually in the Police Department) in the comparable communities, most noted that the restrictions placed were not able to be fully enforced due to the nature of fireworks. Citations can only be issued when the officer directly sees a citizen lighting the firework which makes enforcement difficult. In several instances, it was noted that an increase in restriction placed a large burden on the police force that would take away from more emergent first responder needs during that time.

Over the past ten years, the Board has reviewed and altered the fireworks ordinance multiple times. These reviews have resulted in lengthening the time allowed to discharge fireworks and adding the restriction on the discharge of bottle rockets. As outlined above, the most significant concern with enforcing any fireworks restrictions is that an officer must observe the violation in order to be able to issue a citation. The only other option is for a witness to file a complaint and be willing to testify in court. both of which are very rare.

This year, officers responded to 19 fireworks complaints during the months of June and July. This compares to 18 complaints in 2020, 21 in 2019 and 31 in 2018. Typically, these complaints start a week before the holiday, and persist for 3 to 4 days afterwards.

Staff is seeking direction from the Board regarding desired restriction changes, if any.
