AGENDA ITEM: Resolution 1611, Awarding Bid No. 26-12 Raintree Waterline Replacement.

REQUESTED BOARD ACTION

A motion to approve Resolution 1611, awarding Bid No. 26-12 Raintree Waterline Replacement to Menke Excavating, LLC in the amount of \$117,630.

SUMMARY

The Raintree Waterline Replacement project includes replacement of an old waterline that crosses the creek south of Raintree Lane and has experienced multiple leaks. This project will replace the existing clay waterline with new PVC and fused pipe water main. The City opened bids on August 11, 2026, and received four bids.

Staff recommends award of the lowest bid submitted by Menke Excavating LLC, in an amount not to exceed \$117,630.

PREVIOUS ACTION

The board adopted the FY26 budget which included this project.

POLICY ISSUE

Maintaining infrastructure.

FINANCIAL CONSIDERATIONS

This project is included in the 2026 Budget in the amount of \$75,000. This fund has some savings from other projects that will not be able to move forward in FY26 therefore there are sufficient project savings to fund this project.

RESOLUTION 1611

A RESOLUTION AWARDING BID NO. 26-12 TO MENKE EXCAVATING LLC, FOR THE RAINTREE WATER LINE REPLACEMENT IN THE AMOUNT NOT TO EXCEED \$117,630

WHEREAS, as outlined in the City Purchasing Policy, four bids were received, opened, and read aloud on August 11, 2026, for Bid No. 26-12, Raintree Waterline Replacement; and

WHEREAS, after review of the bids received and completion of reference checks, staff recommends awarding Bid No. 26-12 to Menke Excavating LLC as the most responsive and best bid, and the bid most advantageous to the City, in an amount not to exceed \$117,630.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF SMITHVILLE, MISSOURI, AS FOLLOWS:

THAT Bid No. 26-12 is hereby awarded to Menke Excavating LLC, in the amount of \$117,630, the construction contract in substantially the form as attached hereto as **Exhibit A**, incorporated into this resolution as if fully set forth herein, is approved, and the Mayor is authorized to execute the construction contract on behalf of the City.
