We did receive PPP money on April 11th which greatly helped us with payroll, our problem now is the extensive PPE we must purchase to work. We all are wearing KN95 masks with level 1 masks over them since we have to reuse them for days to save money. Also face shields must be worn each day and gowns are supposed to be changed after each patient. We could not afford to purchase gowns to change after each patients but did purchase enough to change after high aerosol procedures. We had to purchase medical grade air purifiers, construct plexiglass barriers, purchase extra hand sanitizer and UV sterilizers to sterilize our masks, phones and watches. We also have asked all the staff to leave a pair of shoes at the office but we have been unable to purchase work shoes for them due to cost. We would like to provide those since we are asking them to leave them at the office. These are all costs NOT covered by the PPP loan. Many of these we will have to continue purchasing during this pandemic.

How will this grant help you get through the COVID-19 crisis: This will help us to have plenty of PPE as we do dentistry will help us keep our employees safe and our patients who come to see us in smithville safe. Costs are so high for PPE right now, and the CDC recommendations for dental professionals are so extreme that we have spent thousands to follow all recommendations, yet we could still do more if we could afford to. We would like to purchase more gowns, more KN95 masks, work shoes and even aerosol reducer vauumes for dental offices that we haven't been able to afford purchasing yet. Getting some coverage for all the extra PPE would be a huge stress relief on our business.

Smithville Music has served the Smithville community for over 37 years. In that time I have moved twice, one by choice and this last move was forced upon me. I starts out down town in 1983 as the only instructor then shortly added a piano instructor. I now have 7 independent contractors working for me. I moved to 1601 S. 169 hwy after about 10 years and stayed there over the following 25 years until notified I would have to vacate by May 31, 2020. Then the covid hit, shutting down all in store business. While we were able to move many students to an online platform we still suffered aprox. 30% loss of students plus the total loss of retail and repair business. Moving expenses mostly had to come from credit cards and out of pocket. This at a time when my wife's work was also cut back about 25%. You will see expense for signage and the \$400 for sign permit to the city. Also I had to have 3 pianos moved the rest my wife and I moved ourselves. Due to the covid issue I had to rent a much larger space for our studio (aprox twice the size) as it is no longer safe to have the 10x6' teaching studios we had at the other location. Thus my rent and utilities are much higher. Also due to having to move students to an online platform for covid, I had to upgrade my internet, computers and online accounts. I had to switch all payments to "PayPal" which also has taken a percentage form my income. Business has come back to some degree however some lessons (such as voice and woodwinds) have had to stay online for safety reasons and will remain so in the foreseeable future, which cuts down any chance for growth in these areas.

I have received a SBA EIDL loan for \$12,500.00, they also sent me another \$1000.00(I do not know why this \$1000 was sent, at this time I have yet to receive any paper work). These are low interest but must be repaid over a period of time (not forgivable).
