AGENDA ITEM: Resolution 1235, Playground Resurfacing at Heritage and Smith's Fork Park

REQUESTED BOARD ACTION:

A motion to approve Resolution 1235, authorizing the expenditure for the resurfacing of Heritage Park and Smith's Fork Park playgrounds through the cooperative agreement with Sourcewell to Next Generation Recreation in the amount of \$179,369.

SUMMARY:

Staff has gathered bids on resurfacing the playgrounds at Heritage and Smith's Fork Parks. Discussion began at the March 23, 2023 Parks and Recreation Committee meeting. The committee made a recommendation to bring the item to the Board of Aldermen.

In 2018, Heritage Park playground was constructed. Due to budget constraints, playground mulch was placed as the surfacing. To prepare for the future, the playground was designed to easily replace the surfacing once money became available. In 2017, Smith's Fork playground surfacing was patched due to wear and tear. Since being patched, the surfacing has been torn up more. The original surfacing was completed in 2005 with the playground construction. Average life span of pour-n-place surfacing is about 10-15 years.

The estimate to resurface the Heritage Park playground is \$143,369 and the estimate to resurface the Smith's Fork Park playground is \$36,000, for a grand project total of \$179,369.

FINANCIAL CONSIDERATIONS:

Currently, approximately \$84,000 in payment in lieu of dedication funds are in the Capital Project Fund, which houses these payments for the proposed developments. The remaining amount of the resurfacing expense would be covered by the Parks & Stormwater Sales Tax Fund. The fund can adequately handle this cashflow and will be reviewed during the June 20, 2023, Five Year CIP review during the BOA work session.

WHEREAS, the City Code Section 105.080.C authorizes staff to utilize cooperative purchase agreements; and

WHEREAS, staff has made a recommendation to approve the bids from Next Generation Recreation, through the cooperative purchasing agreement with Sourcewell.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF SMITHVILLE, MISSOURI:

THAT staff is hereby authorized and directed to approve the bids from Next Generation Recreation, in the amount \$179,369.
